3 **AMENDING SUPERVISORY DISTRICT BOUNDARIES FOR THE 31<sup>st</sup> AND 37<sup>th</sup> VILLAGE OF**  
4 **VILLAGE OF BROOKLYN AND**  
5 **AMENDING BOUNDARIES FOR SUPERVISORY DISTRICTS 20<sup>TH</sup> AND 22<sup>ND</sup>**  
6 **VILLAGE OF DEFOREST AND**  
7 **AMENDING BOUNDARIES FOR SUPERVISORY DISTRICTS 23<sup>RD</sup> AND 33<sup>RD</sup>**  
8 **CITY OF FITCHBURG**

9 After every census, the County Board adopts a redistricting plan which establishes  
10 supervisory districts with nearly equal populations. From time to time thereafter there occur  
11 annexations, some of which place affected residents of the annexed lands in the position of voting  
12 for different supervisors than do other persons residing in adjacent lands of the annexing  
13 municipality. Many of these situations are addressed by the automatic boundary change provisions  
14 of Dane County ordinances while others require separate action by the County Board. This is one  
15 of the latter. Each change has been adopted by ordinance by the annexing community. These  
16 changes will be reflected for the next election.

18 **WHEREAS** the Village of Brooklyn has annexed from:  
19 Town of Rutland Ordinance Amendment 50.02 land which will now go from the 37<sup>th</sup> Supervisory  
20 District to the 31<sup>st</sup> Supervisory District and Ward #3 in the Village. No population is involved.

21 **WHEREAS** the Village of DeForest has annexed from:  
22 Town of Windsor Ordinance 2014-029, amending Ordinance 2014-023 land which will now go  
23 from the 20<sup>th</sup> Supervisory District to the 22<sup>nd</sup> Supervisory District and Wards 11 and 17. No  
24 population is involved.

25 **WHEREAS** the City of Fitchburg has annexed from:  
26 City of Madison Resolution R-24-15 land which will now go from the 23rd Supervisory District to  
27 the 33rd Supervisory District and to Ward #20 in the City of Fitchburg. No population is involved.

28 **NOW, THEREFORE, BE IT RESOLVED** that the lands described in the attached (available  
29 in the County Clerk's Office) annexation ordinance of the Villages of Brooklyn and DeForest and the  
30 City of Fitchburg be and the same hereby are detached and effective immediately.

31  
32 **BE IT FURTHER RESOLVED** that the County Clerk shall take such steps as are  
33 necessary to permit the residents of the affected areas to vote in the supervisory districts to which  
34 these lands are hereby assigned.
