PROCESS TO PROVIDE PUBLIC COMMENT: ANY MEMBERS OF THE PUBLIC WISHING TO REGISTER TO SPEAK ON/SUPPORT/OPPOSE AN AGENDA ITEM MUST REGISTER USING THE LINK ABOVE (even if you plan to attend using your phone).

In order to testify (provide public comment), you must be in attendance at the meeting via Zoom or phone, you will then either be unmuted or promoted to a panelist and provided time to speak to the body.

Registrations to provide public comment will be accepted until 30 minutes prior to the beginning of the meeting.

Dane County Board of Supervisors Chair Analiese Eicher will conduct a virtual public hearing regarding the vacancy in the District 12 seat on the Dane County Board of Supervisors. The vacancy will be filled with an appointment by the County Board Chair, subject to confirmation by the County Board.

Persons have until 4:30 pm on Wednesday, November 25th to submit nomination papers to the Dane County Clerk for appointments to the vacancy. Those who submit nomination papers and a declaration of candidacy will present their qualifications to the County Board Chair. Other interested parties can provide testimony or register a position on the vacancy at the hearing.

Note: A quorum of the County Board or one or more of its committees may be present at the hearing, but no official business will be conducted.
