This action was postponed to a future Commission meeting.

3/2/21 Redistricting Commission not acted on  
By general consensus, instructed staff to develop a grading system that will:  
1. narrow down submitted maps based on equal population, minimizing crossing of municipal boundaries and number of competitive minority districts, as shown on DistrictBuilder, then  
2. allow the Commission to select maps based on criteria in 1., and have staff perform additional analysis based on other criteria identified in county ordinance.

Staff to follow up with redistricting staff from Utah and with representable.org.  
Staff will report back to Committee at a future meeting.
