8 Enforcement Response Team (ALERT) Hazard Devices Unit (HDU) equipment purchase,
9 Grant Number 2021-HSW-02A-12689; funding is available November 22, 2021 through
10 November 25, 2022.

12 Grant funding of \$74,000 will provide for the purchase of equipment for the Sheriff's
13 Office HDU including two Med-Eng, EOD-10 bomb suits with helmets, batteries with charger
14 kits, face shields, and foot protection. This equipment provides hard and soft protection for
15 bomb technicians when dealing directly with hazardous and/or potentially explosive devices.
16 Specifications of bomb suit and associated equipment is approved by NABSCAB and the FBI.
17 The purchase of this equipment is required to equip HDU members with the necessary tools
18 required to safely and effectively deal with hazardous situations.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Sheriff's Office is authorized to
21 accept \$74,000 from HS WEM DMA to purchase the equipment referenced herein, and on
22 behalf of the County of Dane, the County Executive is authorized to execute the grant

2. Emergency response capabilities developed using these grant funds must be made available to other emergency response agencies regionally, as may be required for incident response purposes.
3. Equipment shall be maintained and available to use as intended by the grant for the duration of its useful life. The sub-recipient is required to maintain proper equipment records. Sub-recipient seeking to dispose or transfer ownership of equipment must contact Wisconsin Emergency Management (WEM) Homeland Security Staff to obtain the Homeland Security Equipment Disposition Form, and further directions. Agreement Articles for Federal Fiscal Year 2021 Homeland Security Awards

Article I - Summary Description of Award

The purpose of the FY 2021 HSGP is to support state and local efforts to prevent terrorism and other catastrophic events and to prepare the Nation for the threats and hazards that pose the greatest risk to the security of the United States. The HSGP provides funding to implement investments that build, sustain, and deliver the 32 core capabilities essential to achieving the National Preparedness Goal of a secure and resilient Nation. Among the five basic homeland security missions noted in the DHS Quadrennial Homeland Security Review, HSGP supports the goal to Strengthen National Preparedness and Resilience. The building, sustainment, and delivery of these core capabilities are not exclusive to any single level of government, organization, or community, but rather, require the combined effort of the whole community. This HSGP award consists of State Homeland Security Program (SHSP) funding in the amount of \$4,602,500. This grant program funds a range of activities, including planning, organization, equipment purchase, training, exercises, and management and administration across all core capabilities and mission areas.
