2 3 4	ESTABLISHING AN INDEPENDENT INVESTIGATION OF THE HENRY VILAS ZOO
5 6 7 8	The Henry Vilas Zoo is one of Dane County's most treasured assets and is one of the very few free zoos left in the United States. It is accredited by the Association of Zoos and Aquariums, which is the gold standard of accreditation for zoos, and which is achieved by less than 10 percent of wildlife exhibitors in the United States.
9 10 11	On April 17, 2022, the Wisconsin State Journal published an in-depth investigation of the zoo, alleging racism, retaliation against zoo employees for union activities, animal neglect, and other allegations.
12 13 14	On April 24, 2022, in an editorial titled "Zoo Needs Independent Investigation," the Wisconsin State Journal editorial board called for an independent investigation of the zoo.
15 16 17 18	Under DCO 7.11(7), the county board and its standing committees "shall continually monitor the performance of departments and agencies in carrying out the policies of Dane County."
19 20 21 22	Wis. Stat. 59.51 grants the county board broad authority to "represent the county" and "have the management of the business and concerns of the county in all cases where no other provision is made."
22 23 24 25 26 27 28 29 30 31 32	The county board is aware that the Department of Administration has conducted an investigation of Henry Vilas Zoo operations and is working with zoo management to remedy the issues identified in that investigation. In no way does the county board question the hard work that has been, and continues to be, applied to that effort by county staff. However, the county board also finds that the concerns identified by the Wisconsin State Journal are severe enough that an independent, third-party investigation is warranted and necessary to restore public trust in the zoo, ensure that all zoo employees are treated fairly, and to ensure that animals are being humanely cared for.
32 33 34 35 36	NOW, THEREFORE, BE IT RESOLVED that the Dane County Board Chair shall select and appoint a retired Circuit Court Judge as a special investigator to lead an independent investigation of the zoo.
37 38 39 40	BE IT FURTHER RESOLVED that the scope of the independent investigation shall include all issues raised in the Wisconsin State Journal's report, including but not limited to:
41 42 43	 allegations of racism by zoo management allegations of retaliation for union activity allegations of retaliation for whistleblowing

44 45 46 47 48	 allegations that employees have been unequally disciplined allegations that animals at the zoo have been neglected or mistreated allegations that zoo employees have left their jobs due to a hostile work environment
49 50 51 52 53	BE IT FURTHER RESOLVED that the independent investigation examine issues to determine whether policies, including those in Dane County Ordinance Chapter 18 and the Employee Benefits Handbook, are being carried out and provide recommendations to better implement policies.
53 54 55 56 57 58	BE IT FURTHER RESOLVED that the special investigator shall issue a written report, including specific recommendations for reforms at the zoo, and shall appear at a meeting of the Dane County Public Works and Transportation Committee to discuss the investigative report and take questions from the committee.
59 60 61	BE IT FURTHER RESOLVED that \$50,000 shall be appropriated from the county board's program evaluation budget line for the independent investigation.
62 63 64 65 66	BE IT FURTHER RESOLVED that the retired judge who is appointed to be the special investigator shall bill their time at the rate of \$200/hour, and the special investigator shall further be authorized to bill for clerical and other staff assistance and necessary expenses, not to exceed the \$50,000 total budget for this investigation.
67 68 69 70	BE IT FURTHER RESOLVED that the special investigator shall have use of the county board's office suite, if needed, during the investigation to conduct meetings and interviews.
70 71 72 73	BE IT FINALLY RESOLVED that the independent investigation and written report shall be completed by no later than October 1, 2022, and shall be presented to a meeting of the Committee of the Whole of the County Board as soon as possible thereafter.
