AMENDING CHAPTER 79 OF THE DANE COUNTY CODE OF ORDINANCES, COUNTY HIGHWAY ACCESS CONTROL

 This ordinance amendment proposes an increase in fees for permits to access County Trunk Highways or to work in County Trunk Highway right-of-way.

Current Policy or Practice -  
 Current practice does not allow applicants to complete the application and pay online.

 Revenue for permits will be increased to allow for implementation of an online permitting software application which will increase efficiency in the processing of permits and allow for credit card payments to be accepted.
