APPROVING COOPERATION AGREEMENT WITH CITY OF FITCHBURG FOR PARTICIPATION IN THE DANE COUNTY URBAN COUNTY CONSORTIUM DCDHS- HAA DIVISION

Policy Analysis Statement:

Brief Description of Proposal -

The City of Fitchburg has elected to continue participation in the UCC program for the upcoming requalification period, and wishes to enter into a new Cooperation Agreement with Dane County. An executed Cooperation Agreement must be signed by the County and submitted to HUD for approval.

This resolution authorizes the signing of a Cooperation Agreement with the City of Fitchburg and submit the signed agreement to the U.S. Department of Housing and Urban Development for the purpose of continuing the inclusion of the City Fitchburg in the Dane County Urban County Consortium in 2023.
