AUTHORIZING SECOND AMENDMENT OF PURCHASE OF SERVICES AGREEMENT FOR AIRPORT DATABASE CONVERSION AND ON CALL TECHNICAL SERVICES
Dane County Regional Airport

Policy Analysis Statement:

Brief Description of Proposal -

This resolution would approve a second amendment to the purchase of services agreement between the Airport and Peterson Technology Group, LLC related to the conversion of the Airport Operations Database from Access to SQL and additional on call technical services..The extension is to continue provision by Peterson Technology Group of on call technical services only. Peterson Technology Group, LLC is the only option to support the unique needs of the Airport. The Airport is requesting approval of this amendment as an exception to the maximum term length and rebidding requirements of Chapter 25.

Current Policy or Practice -

Database conversion and related technical services are essential to continued Airport operations. The Peterson Technology Group, LLC has the unique and singularly available ability to provide these database and technical services, and is the only option to meet the Airport's need to maintain and support the current airport operations system.
