**AUTHORIZING AN AGREEMENT TO ACCEPT GRANT FUNDING FOR THE PURCHASE  
OF COMMUNICATION HEADSET EQUIPMENT**

The Homeland Security (HS) – Wisconsin Emergency Management (WEM), Wisconsin Department of Military Affairs Grant Program is providing \$8,000 funding to the Sheriff's Office to purchase communication headset equipment; Grant Number 2022-HSW-02A-13218, funding is available December, 30 2022 through October 27, 2023.

This grant supports the Aligned Law Enforcement Response Team initiative by providing funding to purchase communication headset equipment for the Sheriff's Office Tactical Response Team (TRT). This specialized communication headset equipment is designed with push-to-talk and hearing protection, to help prevent hearing loss and facilitate the sharing of information between TRT members and their command during high risk operations.

**NOW, THEREFORE, BE IT RESOLVED** that the Sheriff's Office is authorized to accept \$8,000 from HS WEM to purchase communication headset equipment, and on behalf of the County of Dane, the County Executive is authorized to execute an agreement embodying the above provisions; and

**BE IT FURTHER RESOLVED** that \$8,000 is appropriated as additional revenue in the Sheriff's Office, Field Services Division, TRT Grant Revenue (SHRFFLD 80728) and is credited to the General Fund; and

**BE IT FINALLY RESOLVED** that \$8,000 is transferred from the General Fund to Sheriff's Office, Field Services Division, TRT Equipment and Uniforms (SHRFFLD 48848).

# Agreement Articles for Federal Fiscal Year 2022 Homeland Security Awards

## Article I - Summary Description of Award

The purpose of the FY 2021 HSGP is to support state and local efforts to prevent terrorism and other catastrophic events and to prepare the Nation for the threats and hazards that pose the greatest risk to the security of the United States. The HSGP provides funding to implement investments that build, sustain, and deliver the 32 core capabilities essential to achieving the National Preparedness Goal of a secure and resilient Nation. Among the five basic homeland security missions noted in the DHS Quadrennial Homeland Security Review, HSGP supports the goal to Strengthen National Preparedness and Resilience. The building, sustainment, and delivery of these core capabilities are not exclusive to any single level of government, organization, or community, but rather, require the combined effort of the whole community. This HSGP award consists of State Homeland Security Program (SHSP) funding in the amount of \$4,602,500. This grant program funds a range of activities, including planning, organization, equipment purchase, training, exercises, and management and administration across all core capabilities and mission areas.

## Article II - Limited English Proficiency (Civil Rights Act of 1964, Title VI)

Recipients must comply with Title VI of the Civil Rights Act of 1964, (42 U.S.C. section 2000d et seq.) prohibition against discrimination on the basis of national origin, which requires that recipients of federal financial assistance take reasonable steps to provide meaningful access to persons with limited English proficiency (LEP) to their programs and services.
