BACKGROUND---COMMUNITY MEMBERS APPOINTMENT TO THE CJC (EXEC)

- OA 28 REQUIRES TWO MEMBERS “IMPACTED BY INCARCERATION OR BEEN DIRECTLY IMPACTED BY THE CRIMINAL JUSTICE SYSTEM”, AND ONE MEMBER “WITH BEHAVIORAL HEALTH EXPERTISE” APPOINTED BY THE CHAIR OF THE COMMUNITY JUSTICE COUNCIL
- 2 MEMBERS SHALL BE CHOSEN FROM A LIST SUBMITTED BY RELEVANT COMMUNITY ORGANIZATIONS INCLUDING BUT **NOT LIMITED** TO NEHEMIAH, JUSTDANE, MOSES, EXPO, FREE, FOCUSED INTERPRETATION, AND CENTRO HISPANO.
- 1 MEMBER APPOINTED FROM A LIST OF RECOMMENDATIONS SUBMITTED BY RELEVANT COMMUNITY ORGANIZATIONS INCLUDING BUT **NOT LIMITED** TO RECOVERY COALITION, NAMI, HOMELESS SERVICES CONSORTIUM AND CHRYSALIS ,TRANSITIONAL PROVISION.
- THE CHAIR OF THE COMMUNITY JUSTICE COUNCIL SHALL DESIGNATE THE INITIAL TERMS OF THE APPOINTEES IN SUB. (1)(A)7 AND (1)(A)8 IN ORDER TO ACHIEVE STAGGERED TERMS

OTHER ORGANIZATIONS/AGENCIES TO CONSIDER? DISCUSSION

- **CJC MEMBERS** COMMENT ON POTENTIAL OTHER AGENCIES/ORGANIZATIONS FOR THE CJC CHAIR TO CONSIDER:

 - WHO HAS LIVED EXPERIENCES OF INCARCERATION OR HAS BEEN DIRECTLY IMPACTED BY THE CRIMINAL JUSTICE SYSTEM

CJC SUBCOMMITTEES

- **CJC-PRETRIAL SUBCOMMITTEE:** “TWO PERSONS FROM DIVERSE BACKGROUNDS WHO HAVE LIVED EXPERIENCES OF INCARCERATION OR HAVE BEEN DIRECTLY IMPACTED BY THE CRIMINAL JUSTICE SYSTEM SELECTED FROM A LIST OF APPLICANTS AND APPOINTED BY THE CHAIR OF THE COMMUNITY JUSTICE COUNCIL;”
- **CJC-RACIAL DISPARITIES SUBCOMMITTEE:** “TWO PERSONS FROM DIVERSE BACKGROUNDS WHO HAVE LIVED EXPERIENCES OF INCARCERATION OR HAVE BEEN DIRECTLY IMPACTED BY THE CRIMINAL JUSTICE SYSTEM SELECTED FROM A LIST OF APPLICANTS AND APPOINTED BY THE CHAIR OF THE COMMUNITY JUSTICE COUNCIL;”
- **CJC-BEHAVIORAL HEALTH SUBCOMMITTEE:** “ONE ADDITIONAL PUBLIC MEMBER WITH BEHAVIORAL HEALTH EXPERTISE SELECTED FROM A LIST OF APPLICANTS AND APPOINTED BY THE CHAIR OF THE COMMUNITY JUSTICE COUNCIL.;”

NUMBER OF APPOINTEES

- 6 INDIVIDUALS WITH LIVED EXPERIENCE
- 2 INDIVIDUALS WITH BEHAVIORAL HEALTH EXPERTISE
- THERE ARE 3 REASONS TO APPOINT DIFFERENT PEOPLE TO EACH BODY:
 - MORE INDIVIDUAL VOICES ARE HEARD AND AT THE TABLE
 - COMMUNITY MEMBER WORKLOAD CONSIDERATIONS
 - IF WORKLOAD IS TOO MUCH, AND ATTENDANCE SUFFERS, WE LOSE QUORUM.

 - CJC STAFF WILL ASSIST WITH COMMITTEE ONBOARDING, TO INCLUDE:
 - CJC BACKGROUND
 - ROBERTS RULES
 - CURRENT CJC INITIATIVES
