

AUTHORIZING THE TAX DEEDING OF TAX DELINQUENT PROPERTIES

Pursuant to its authority in section 74.57 of the Wisconsin Statutes, the Dane County Treasurer has issued tax certificates for the enumerated tax parcels on the attachment.

For each enumerated parcel on said attachment, greater than two years have elapsed since issuance of the tax certificate, and legal notice has been provided to all parties entitled thereto in accordance with sections 74.59, 75.07, and 75.12 of the Wisconsin Statutes.

NOW, THEREFORE, BE IT RESOLVED that the Dane County Board of Supervisors orders the Dane County Treasurer to seek the execution of a tax deed on the aforementioned enumerated parcels in accordance with section 75.14(1) of the Wisconsin Statutes.
