AMENDMENT NO. 1 OF PROFESSIONAL SERVICE AGREEMENT WITH WOLD
ARCHITECTS AND ENGINEERS FOR ARCHITECTURAL / ENGINEERING DESIGN
SERVICES FOR NEW PUBLIC SAFETY COMMUNICATIONS FACILITY

The Department of Administration-Public Works Engineering Division awarded a contract to Wold Architects and Engineers for Architectural / Engineering Design Services for New Public Safety Communications Facility, RFP 322013.

The following change is requested: Professional Service Agreement Amendment No. 1 to amend the Agreement in order to extend A/E's contractual obligations through completion of the design and professional services to administer construction as originally proposed by A/E in their response to RFP 322013.

There are sufficient funds available for this project. The term of the borrowing used to support this project will be 20 years.

NOW, THEREFORE, BE IT RESOLVED that Contract Amendment No. 1 for a total increase of \$668,362.00 be approved to the Agreement with Wold Architects and Engineers for the above listed changes; and

BE IT FINALLY RESOLVED that the Department of Administration-Public Works Engineering Division be directed to ensure complete performance of the Contract.

THIS AGREEMENT is between the County of Dane, by its Department of Administration, hereinafter referred to as “COUNTY”, and Wold Architects and Engineers, 220 N. Smith St., Suite 310, Palatine, IL 60067, hereinafter called the “A/E”.

WITNESSETH

WHEREAS, COUNTY has secured architectural / engineering services for a project described as follows:

Architectural / Engineering Design Services for New Public Safety Communications Facility

WHEREAS, A/E, and COUNTY, by a separate document, Professional Services Agreement No. 14814 (hereafter, “Agreement”), did on August 24, 2022 enter into a contractual relationship pursuant to which A/E is to provide architectural & engineering services in the design of the New Public Safety Communications Facility through Design Development Phase, and,

WHEREAS, A/E and COUNTY wish to amend the Agreement in order to extend A/E’s contractual obligations through completion of the design and professional services to administer construction as originally proposed by A/E in their response to RFP 322013.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

1. The Agreement shall remain in full force and effect unchanged in any manner by this amendment except as changes are expressly set forth herein. This Amendment shall control only to the extent of any conflict between the terms of the Agreement and this Amendment.
2. **ARTICLE 4**, of the Agreement is amended by adding the following:
 - 4.A.1)a. The COUNTY will pay the A/E a lump sum fee of \$668,362 for Design Development, Construction Documents, Bidding, Construction Administration, and Commissioning Phases.

IN WITNESS WHEREOF, COUNTY and the A/E have executed this Amendment as of the above date.
