


Disability & Aging Services

Disability & Aging Services Highlights 2022

Adult Protective Services

Adults & Elders At-Risk for Abuse/Neglect

- 3,530 Calls to APS Helpline
- 470 Reports Investigated (60+ year olds), 95 more than 2021
- 96 Reports Investigated (adults age 18-59)
- \$100,000 in Hoarding Clean-up grants provided

Guardianship & Protective Placements

- 528 Protective Placements
- 27 Guardianship Only Cases
- 184 New Cases
- 90 Comprehensive Evaluations for Court
- 309 Court Hearings, 50 Contested

Alzheimer's Family Caregiver Support

- \$140,000 in grants to 60 Caregivers

Disability Services for Children

Birth to 3

- 1200 B-3 referrals processed
- 920 Children enrolled in B-3
- 435 1st Q Kids enrolled in B-3 2023

Children's Long Term Support Program (CLTS)

- 1939 CLTS Kids enrolled
- 433 Kids on CLTS Waitlist
- 186 Contracts with Service Providers

Vocational Futures & Community/School Coordination

- 17 students provided services during the 2022 school year
- 11 graduated and are employed 10-11 hours per week earning \$10-11.50/ hr.
- 4 more graduated now in volunteer jobs, 1 moved and 1 continues in the program.
- 18 served in 2023 school year and 25 interested in enrolling for graduation in 2024.
