 - Properties with no residential structure were excluded.


Response Overview

- Average Time Spent: 4:40s (Completed Survey Time: 5:44s)




Q2 How long have you lived here?



Q3 Do you work in a field relating to cultural and historic preservation? (planning, architecture, etc.)




Q4 Do you have any involvement with your local historical society?




Q6 The following are statements that suggest choices about future directions for cultural and historic preservation in Dane County. Please rate each.


- Historic buildings are an important part of my community's heritage and identity.

- Dane County has done an adequate job of protecting cultural and historic resources in our community.




Q7 How knowledgeable would you say you are regarding archeological, historic, and cultural sites in your town?

"The viaduct bridge on Viaduct Road. Ice age trail Marsh."


"...our house used to be a one room school house."

Sample Responses:

"Not so much in Blooming Grove but yes in Monona and Madison very nearby."

"Obviously there are many in Madison.

"In Windsor - all activities take place at the parks."

"Dunn Heritage Park on Lake Waubesa."

"Dorf Haus [supper club] is largely a place for social gatherings."

"...American Legion Post 360. The former Westport Town Hall hosted folk dancing for many years but was redeveloped."

Do you have any additional comments or concerns about historic and cultural preservation in your community?

"I think it is better to have county-wide plans and systems rather than depending on individual towns to designate and regulate archaeological and historic sites."

"I...believe that each situation is unique and while there should be some protections and potential financial options available for owners and communities to save their treasures, there are situations where preservation is not feasible..."

"There are plans done...but then very little is done to implement or protect historic places."

"I have problems walking so it is difficult to access some of these places. Since I grew up here, I have many memories of buildings which have changed over the years and I would like to see more photos of the original buildings." Saving some of the past with its customs, beauty, design etc. let's future and current folks know what came before..it cherishes values that seem to slip away very quickly in todays fast paced society!

"More efforts need to be made to help the population that pays for these efforts (through taxes) understand cultural preservation. This creates appreciation, use, and justification for expenditures to make such efforts."
