## LANGUAGE ACCESS

 We have a support staff member who speaks Spanish which is helpful with phone calls and walk in members of the public

 Clerk Of Courts staff assist with scheduling interpreters for appointments and with occasional document translation when available

 Recently purchased subscription to DeepL which allows us to translate documents, emails and letters into Spanish and 30 other languages instantly

 An online Spanish Parent Education option is now available. We do not have a Spanish in-person option.

## LANGUAGE ACCESS

 We have a device from IM that allows interpretation of vorbal conversations if we know the language being spoken

 Court certified interpreter's are difficult to find for some languages and sometimes we need to reach out unexpectedly. In those instances we use the Language Line.

• Court certified translator's are difficult to find for some languages

#### UNMET NEEDS

• The need for updated equipment and software continues to affect operations at FCS.

- The FCS training budget has continually been reduced. Counselors sometimes have to pay for training to maintain their required licensure out of pocket. License renewal fees are out of pocket as well. High quality training specific to this field helps counselors feel confident when testifying as the Court's expert witness.
- The database upgrade has not worked as hoped. For instance, we are still unable to run our own reports regarding case assignments, fees outstanding, Parent Education attendance, and data about client populations. This information would help us be responsive to our evolving client base and changing needs.

### UNMET NEEDS

The 4 years of backscanning paper files is finishing up and is freeing up some space

Our space is being used differently since the pandemic. The top three priorities are as follows:

We need a new playroom that is larger and more inclusive of disabilities, older children and larger families

Designated space for file reviews

Private staff space
