The new rental amount is \$2,073.51 per month for an annual payment of \$24,882.15. The new lease contains two options to renew the lease for additional one year terms at an increase of 2.5% per renewal, subject to the existing lease terms and conditions. Sunshine Place will provide lawn care and snow removal services. DCDHS will be responsible for telephone and internet.
