AUTHORIZING PARC & RIDE GRANT AWARD TO CITY OF MIDDLETON

Policy Analysis Statement:

Brief Description of Proposal -

Dane County awards grants to local unit government or nonprofit organizations to develop regional bicycle and pedestrian trails and bike playgrounds. The project is a partnership between the City of Middleton, CORP and Dane County. County funds cannot be released to CORP as none of the costs were incurred directly by CORP. Therefore, funds will be released to City of Middleton, who took the lead on construction of the facility.

Current Policy or Practice -

Significant contracts require County Board approval.

This grant award will create a new regional bike amenity in Dane County.
