AUTHORIZING ACCEPTANCE OF GRANT FUNDING FROM THE FY 2023 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) PROGRAM

## **Policy Analysis Statement:**

## Brief Description of Proposal -

Request authorization to accept grant funding from the FY 2023 Edward Byrne Memorial Justice Assistance Grant Program in the amount of \$28,134 to be used as follows: \$7,480 to the Sheriff's Office to purchase a narcotics evidence cabinet, \$13,859 for the Dane County Drug Court Treatment Program, and \$6,795 for the Dane County District Attorney Victim Emergency Funds.

Current Policy or Practice -

Acceptance of grant funding requires County Board approval.

## Impact of Adopting Proposal -

A narcotics evidence storage cabinet is required for the Sheriff's Office for the safe storage of confiscated hazardous drugs and chemicals to minimize the health and environmental risks of handling chemicals and other materials associated with drug evidence. Evidence rooms can become contaminated by fumes, odors, and airborne particulates/pathogens from confiscated chemical substances, when drug evidence is not stored properly.
