AMENDING THE OFFICE OF ENERGY & CLIMATE CHANGE BUDGET TO ACCEPT A US DEPARTMENT OF TRANSPORTATION GRANT TO EXPAND PUBLIC ELECTRIC VEHICLE CHARGING ACROSS THE COUNTY

**Policy Analysis Statement:**

Brief Description of Proposal -

The Office of Energy & Climate Change (OECC) is receiving a US Department of Transportation (DOT) Federal Highway Administration (FHWA) grant to finance more public electric vehicle charging in Dane County. The initiative will occur in two phases with \$1,297,759.45 of the funding available now and the remaining \$11,900,367.32 available after the required NEPA reviews are complete for all proposed station sites.

Current Policy or Practice -

Amend the budget through County Board and County Executive approval to create revenue and expenditures lines for the DOT FHWA funds.

Impact of Adopting Proposal -

OECC will set up the EV Advisory Commission, hire a design engineer and work with the EV Advisory Commission to finalize sites and then pursue the NEPA review. (In the second phase, following NEPA review, OECC will bid out the installation of EV charging stations at the selected sites.)
