AWARD OF DANECOM RADIO SYSTEM MAINTENANCE CONTRACT AMENDMENT

Public Safety Communications (PSC) currently has a contract with RACOM to perform maintenance for the DaneCom system, which includes software updates and a 24 hour, 7 day a week network operations center that monitors the health and functionality of the DaneCom radio system. The DaneCom radio system is a critical and essential element of communications between the PSC and field responders. This contract amendment is for one year and is awarded to RACOM beginning on January 1, 2025.

NOW, THEREFORE, BE IT RESOLVED that the Dane County Board of Supervisors does authorize a one year contract to RACOM with the total cost being \$787,996.00 and that the County Executive and County Clerk are authorized to execute the agreement.



DANE COUNTY CONTRACT

ADDENDUM # 14911D

Revised 01/2022

THIS ADDENDUM, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and RACOM Corporation (hereinafter, "Provider").

WITNESSETH:

WHEREAS Provider and County, by a separate document (hereinafter, the "Master Agreement"), Dane County Contract #14911, have previously entered into a contractual relationship pursuant to which Provider provides DaneCom Radio System Maintenance, and

WHEREAS County and Provider wish to amend the Master Agreement in order to extend the term of the contract.

NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
2. The Master Agreement, and any amendment or addendum to it, may be executed and transmitted to any other party by legible facsimile reproduction or by scanned legible electronic PDF copy, and utilized in all respects as, an original, wet-inked manually executed document. Further, the Master Agreement and any amendment or addendum thereto, may be stored and reproduced by each party electronically, photographically, by photocopy or other similar process, and each party may at its option destroy any original document so reproduced. All parties hereto stipulate that any such legible reproduction shall be admissible in evidence as the original itself in any judicial, arbitration or administrative proceeding whether or not the original is in existence and whether or not such reproduction was made by each party in the regular course of business. This term does not apply to the service of notices under the Master Agreement, or any subsequent amendment or addendum.
3. The term of the contract is extended through December 31, 2025 to continue the program for DaneCom Radio System Maintenance, at a cost of \$787,996.00.

**P25 COMMUNICATION SYSTEMS MAINTENANCE QUOTATION FOR

RACOM and Dane County entered into a maintenance contract based on an existing Software FX Agreement (Exhibit 15D) and a System Maintenance Agreement (Exhibit 15F) in place with L3Harris that expired on 12/31/22. RACOM hereby proposes extending that agreement for calendar year 2025 at a rate of 787,996.00.

During the term of this agreement, it is recommended the parties also develop a more comprehensive proposal for the communication system maintenance for future years to extend the useful life of the system.

Proposed Term

January 1, 2025 through December 31, 2025.

Service Response

Standard service is provided M-F, 8 AM to 5 PM, excluding holidays. Local calls during normal business hours are answered live at the local office to provide an immediate response.

Emergency Services are also included. After-hours calls are answered immediately at RACOM's Network Control Center (NCC) which is staffed 24 x 7 x 365.

Technicians are dispatched immediately for any emergency service required. Non-critical issues will be logged for response during normal business hours.

Exclusions

This quotation does not cover acts of God, equipment abuse, or services beyond the scope of the previously mentioned contracts it replaces. RACOM reserves the right to determine if equipment is no longer repairable or has reached end-of-life and will make recommendations for replacement or upgrade options.

Payment Terms

The following annual payment is due Net 30 as follows.

RACOM will provide other services beyond the scope of this agreement at the following hourly rates:

- Technician \$160
- Engineering \$180
- Project Management \$200
- Overtime \$240
