Dane County Department of Human Services is involved in a program of providing more localized services in the communities identified as needing those services most. One such program is the Joining Forces for Families (JFF) Program. The Joining Forces for Families program has secured office space in a a building, owned by Cyrena N. Pondrom and managed by Investment Planning Corporation, located at 2225 Allied Drive, Apartments #1,2, 3 and 4, Madison, Wisconsin. The space is utilized by a Dane County Community social worker and other JFF partners.

Current Policy or Practice -

Leases require County Board approval.

## Impact of Adopting Proposal -

Authorizes the County Executive and County Clerk to execute a lease for space for the JFF Program in a building 2225 Allied Drive, Apartments #1,2, 3 and 4. This resolution is to pay for the monthly rental payment of \$2,260 per month to cover costs related to occupying this space during the lease term of twelve months (01/01/2014 to 12/31/14). This rental rate is an increase of \$20 per month per unit up from \$2,180 per month or \$960 per year. There has not been an increase in the rental rates since 2007. There are two one-year renewal options included in the lease. Adequate funds are budgeted for lease payments and electric costs.
