## APPROVING THE DIVISION OF JOINTLY OWNED LAND IN THE TOWN OF MEDINA

Brief Description of Proposal -

Joyce M. Baer passed away in 2013 and left her undivided one-half ownership in 11.4 acres as a gift to Dane County, which the County accepted through 2014 RES-397, subject to the reservation of a life estate for the benefit of George Socha Sr. It is in Dane County's and George Socha Sr.'s best interest to allocate this parcel so that each party has full fee interest in a portion of this 11.4 acre site.

Current Policy or Practice -

Division of jointly owned land requires County Board approval.

Impact of Adopting Proposal -

Dane County would assume a 100% interest in the southern 8.64 acres of vacant open lands. As part of this land division, George Socha would retain a life estate on the 8.6 vacant acres, and the County would retain a right of first offer on the 2.8 acres with the residence and outbuildings. It is in Dane County's and George Socha Sr.'s best interest to allocate this parcel so that each party has full fee interest in a portion of this 11.4 acre site.
