Brief Description of Proposal -

Badger Prairie Health Care Center currently uses hardware/software referred to IMS2 for maintenance of the Ascom phone equipment. This phone equipment also doubles as the nurse call system. In August, Badger Prairie was informed that IMS2 is no longer supported by Ascom and Badger Prairie must upgrade to Elise 3, because replacement equipment is no longer available. Badger Prairie Health Care Center is a 24-hour a day facility. The need to have both the phone system and the nurses call system operative at all is of paramount importance. The cost to upgrade both is \$45,000.
