## AMENDMENT EXTENDING THE TERM OF OPERATING AGREEMENT AND TERMINAL BUILDING LEASE OF DELTA AIRLINES, INC.

DANE COUNTY REGIONAL AIRPORT LEASE NO. DCRA 2010-03

THIS AMENDMENT Extending the Term of Operating Agreement and Terminal Building Lease is entered into by and between Delta Airlines, Inc., a corporation organized under Delaware law (hereinafter, "Airline"), and Dane County, a Wisconsin quasi-municipal corporation (hereinafter, "County"), and shall be effective as of the date by which it is fully executed by both parties.

## WITNESSETH:

WHEREAS Airline and County have entered into a Scheduled Airline Operating Agreement and Terminal Building Lease identified as Dane County Lease No. DCRA 2010-03, and have thereafter twice amended said Scheduled Airline Operating Agreement and Terminal Building Lease (hereinafter, as amended, the "Operating Agreement"); and


WHEREAS, pursuant to the terms thereof, the Operating Agreement is effective through December 31, 2014; and

WHEREAS Airline and County desire to amend the Operating Agreement to extend its term for an additional two years;

NOW, THEREFORE, for and in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, Airline and the County do agree as follows:

- 1. The Operating Agreement shall remain in full force and effect unchanged in any manner by this Amendment except for those changes expressly set forth herein.
- 2. The first sentence of Section 2.01 of the Original Agreement is deleted in its entirety and replaced with the following:

This Agreement shall be effective January 1, 2010 and shall continue through December 31, 2016, subject to prior termination as provided in Article 12 herein.
