

Testimony to Personnel and Finance Committee of the Dane County Board of Supervisors

Thank you to the committee for the opportunity to speak in support of restoring funding to the 2016 county budget for the proposed nutrient concentration system.

Clean Lakes Alliance works to improve water quality in the Yahara River watershed with the goal of reducing phosphorus loading to the lakes by 50 percent.

Nutrient concentration systems at community manure digesters have been identified as one of the 14 cost-effective actions in the Yahara CLEAN Strategic Action Plan for Phosphorus Reduction. Agriculture will continue to grow as an industry in Dane County, and we need to support the tools that will help farmers improve nutrient management and reduce the risk of phosphorus loss to our waterways. Clean Lakes Alliance sees the nutrient concentration system as an integral tool in manure and nutrient management, and an important component of the multifaceted strategy to reduce phosphorus loading to our lakes.

Clean Lakes Alliance supported funding for earlier phases of this project for the last two county budgets, and we urge the Personnel & Finance Committee to restore the \$500,000 of funding for this initiative to the 2016 county budget.
