ADJUSTING 2016 REVENUES AND EXPENSES FOR ADULT SERVICES DCDHS - ACS DIVISION

Policy Analysis Statement:

Brief Description of Proposal -

The Area Agency on Aging of Dane County has received two grants that were not included in the 2016 Adopted Budget. A \$30,000 Nutrition Revitalization Grant from the Wisconsin Department of Health Services, and a \$20,000 Falls Prevention Grant from the Wisconsin Institute for Health Aging. They have also arranged for the North Eastside Senior Coalition to provide Older Americans Act funded caregiver support services, the contract is \$44,937 and St. Marys Adult Day Center is serving an increased number of Medicaid Waiver eligible older adults and people with chronic health conditions. The St. Marys program is increased by \$25,282, with the funds transferred from the Individual Payments – CIP II

Budget and professional service contract changes require County Board approval.

Impact of Adopting Proposal -

The Nutrition Revitalization Grant will enable establishing a two day per week congregate meal site in the Meadowood Shopping Center on Raymond Road in Madison; and will offer meals from Main Street Kitchen restaurant one day per week as an option for diners at Stoughton Senior Center; and offer meals at Deforest Family Restaurant one day per week. The Falls Prevention Grant will enable Safe Communities, Inc. to continue coordinating Stepping On classes, an evidenced based falls prevention curriculum, at locations across Dane County in 2016. St. Marys Adult Day Center will serve an increased number of participants. North Eastside Senior Coalition will provide Older Americans Act funded caregiver support services.
