Overall, the February 25, 2016 Post-Election Audit went well.

Originally, the process determined 2 individual wards (City of Madison Ward 98, City of Middleton Ward 4), but when the auditors received the results from the County Clerk, it was realized that public results were posted according to reporting location, which meant City of Middleton required audit of Wards 1-4, 9, 19.

^{**}The discrepancy between the Post-Election Audit Results and the Publicly Reported Results provided by County Clerk is most likely due to human error by auditors extracting files late at night after resolving a computer crash. The image file extraction issue must be resolved before future audits.

Issues with the Audit

In the image files presented for audit, each ballot consists of 2 single image bitmap (pbm) files, 1 for the front, 1 for the rear. Each file is separately zipped. This results in double the number of files than ballots cast in the machine.

These files are not in logical sub-directories. This further obscures unzipping if done manually.

<u>To unzip each file individually is time and cost prohibitive</u>. On the day proceeding the audit, it took 13 hours to unzip these files manually, and it resulted in a computer crash and human error omitting 14 ballot files (7 ballots) from extraction/inclusion in the final audit in the Middleton Ward. (The Madison Ward, roughly 50% smaller and converted earlier in the day on fresh eyes, had no issues.)

At present, there is no way to automatically unzip all files and keep them associated with their file number. Perhaps Dane County Information Technology might have a way to do this; it is sincerely hoped that this can be remedied so that these files can be converted accurately and in a reasonable time frame.

The original source image files are bitmap files of a very small file size (<1MB in general) which do not gain much in the way of compression when zipped. Five thousand image files of this size would take up less than 5GB as unzipped files. The zip process also does not add any encryption for file security. It seems unzipped files would be faster to work with, if the original source files can be provided this way.

In looking ahead to April 2016 and November 2016 where turnout is expected to be significantly larger, it is this process of unzipping files which is the greatest part of the process, and which, if done individually, poses the greatest opportunity for human error.

The audit files were needed to be taken offsite for conversion, not ideal for a transparent audit. Also, the County Clerk required us to use IrfanView to create the Slideshow presentation. When the lead auditor received the county laptop, it did not have a version of IrfanView installed. The software was installed in the audit room during the tech dress rehearsal for the audit the previous day. When the laptop arrived home, the software did not appear on the laptop. This required the auditor to use a personal computer with a copy of IrfanView installed; this is also not ideal for a transparent audit.

Ideally, all work should be done in the City-County Building, in the presence of a minimum of 2 audit personnel at all times, using only County equipment, and seals with Chain-of-Custody paperwork revised for this procedural change.

It is anticipated that once the extraction process is resolved, the audit should be reasonably clear and time involved will be significantly reduced. It is also anticipated that once procedure is worked out that other auditor staff should be able to cycle into the process rather easily.

Action Plan:

- Scott McDonnell should facilitate a meeting with Dane County Information Technology and David Spies
 to review the process to determine any ways to expedite the extraction process. Scott should provide to
 IT and David a 'sandbox' similar to the one used prior to the February 2016 election in order to
 determine how best to extract files.
- Once a process to expedite extraction is identified, tested, and determined to be effective, David Spies should revise the procedure manual and paperwork reflecting suggestions made by auditors during the February 25, 2016 audit as well as changes to the process listed above.
- David Spies should develop a checklist for the actual process of the audit as well as an instructional handout for the auditors to clearly state the procedures and roles each auditor follows in the audit.
- Depending upon how long it will take to extract files, it might be necessary to schedule the April 2016 audit further away from the actual election than the schedule used in February 2016.
- David Spies needs to schedule a date and room for the April 2016 Post Election Audit, secure audit staff and materials, and arrange for parking for auditors on the days of the audit.

6:00 pm: After difficulty completely sealing both new ballot bags (logged on City of Middleton Ward-specific Inspectors Statement), ballots were sealed in bags with the following seal numbers:

Paperwork was initialed by Lead Auditor David Spies and John M. Lehman, Finance Director/Assistant City Administrator for the City of Middleton (as authorized by Middleton City Clerk Lorie J. Burns). Ballots were secured by Lehman in view of Auditors Spies and Becker in a locked closet in the City of Middleton City Hall.

Observations from Post-Election Ballot Audit (City of Middleton)

The discrepancy between the February 25, 2016 Post-Election Audit Results and the Publicly Reported Results provided by County Clerk was most likely due to human error by the lead auditor extracting files late at night after resolving a computer crash.

Paper ballots, although indisputable, took significantly longer to count than electronic ballot images. Even though there were 2 inspectors at the ballot audit whereas 3 were present at the Electronic Voter Machine Image Audit, the amount of time involved with counting and tallying paper ballots took approximately twice as long (approximately 2 hours to count and tally 516 ballots). This audit was for one polling location; with significantly higher turnout in April, August, and November 2016 elections, it is likely that this process will take significantly longer than the 5 hours it took on February 25, 2016. **The Audit perhaps should begin at 9:00 am in April 2016 to facilitate a larger workload.**

It was determined by a conversation between the Dane County Clerk and the Madison City Clerk that the best way to proceed in future post-election audits is to count and tally paper ballots. **This will involve transporting these ballots to the County Clerk's Office in order to maintain chain-of-custody.** It is anticipated that auditors will take custody of the select ward ballot bags from the County Clerk at the time of the Audit, which should be conducted in the City-County Building according to the procedures of open meetings law. Auditors will reseal the ballots in new ballot bags, recording seal numbers to maintain chain-of-custody, and return the bags to the County Clerk at the conclusion of the audit.

Action Plan:

- David Spies should revise the procedure manual and paperwork reflecting suggestions made by auditors during the February 25, 2016 audit as well as changes to the process listed above to reflect a revised paper ballot tally process.
- David Spies should develop a checklist for the actual process of the audit as well as an instructional
 handout for the auditors to clearly state the procedures and roles each auditor follows in the audit.
 Depending upon how long it will take to transport ballot bags from polling locations to the County Clerk,
 it might be necessary to schedule the April 2016 audit further away from the actual election than the
 schedule used in February 2016. Consult Dane County Clerk Scott McDonnell for advice.
- David Spies needs to schedule a date and room for the April 2016 Post Election Audit, secure audit staff and materials, and arrange for parking for auditors on the days of the audit.

Determining Random Selection of Wards for Post-Election Audit

For purposes of randomly identifying a ward with representative size, the following select wards were considered:

- 1) Madison City Wards 1-99
- 2) Middleton City Wards 1-19
- 3) Monona City Wards 1-10
- 4) Oregon Village Wards 1-11
- 5) Stoughton City Wards 1-12
- 6) Sun Prairie City Wards 1-20
- 7) Verona City Wards 1-9

The website Random.org (www.random.org) has contained within it a True Random Number Generator.

Procedure:

For the purposes of this Post-Election Audit, one ward from within the City of Madison (#1) and one ward selected from any of the following communities (Select wards within communities are indicated; not all wards are included):

- 2) City of Middleton (wards 1-19)
- 3) City of Monona (wards 1-10)
- 4) Village of Oregon (wards 1-11)
- 5) City of Stoughton (wards 1-12)
- 6) City of Sun Prairie (wards 1-20)
- 7) City of Verona (wards 1-9)

A. To determine a community other than Madison for audit:

- -Insert "2" in the Min: box of the True Random Number Generator
- -Insert "7" in the Max: box of the True Random Number Generator
- -Click "Generate"

This should determine a community within the communities outlying the City of Madison.

B. Once this community is determined, Use the True Random Number Generator to randomly select a ward within that community for post-election audit.

For example, if the True Random Number Generator selects #5 City of Stoughton (wards 1-12) in Step B,

- -Insert "1" in the Min: box of the True Random Number Generator
- -Insert "12" in the Max" box of the True Random Number Generator
- -Click "Generate"

This should determine a random ward within wards 1-12 of the City of Stoughton for post-election audit.

C. To determine a ward within the City of Madison for audit:

- -Insert "1" in the Min: box of the True Random Number Generator
- -Insert "99" in the Max: box of the True Random Number Generator
- -Click "Generate"

This should determine a random ward within wards 1-99 of the City of Madison for post-election audit.

D. Requesting electronic ballot images for randomly selected wards

Once Steps A, B, & C have been completed, post-election audit staff will request a digital file of the electronic ballot images from the randomly selected wards (Steps B & C) from the Dane County Clerk's Office.
