D. Communications of Staff Including Any Items From Last Meeting

1. Airfield Construction Updates

Deputy Airport Director, Jensen, briefed the subcommittee on the Taxiway Bravo Reconfiguration Project necessitating alternate closures of Runways 18/36 and 3/21 and the South Ramp T-Hangar Re-Paving Project.

Wright briefed the subcommittee on complaint activity. For the previous 6 months, there were 161 complaints from 34 households. Complaints by aircraft type included: Military, 54%; Military Helicopter, 1%; Airlines, 33%; Unknown, 1%, General Aviation, 11%; and Cargo, 0%. The number of aircraft operations was up 5% from the same 6 month period, last year.

G. Public Comment on Items not on the Agenda

There was no public comment on items not on the agenda.

H. Review of Noise Audit Results

Wright briefed the subcommittee on the noise audit results. During the last 6 months, there were 5633 aircraft operations recorded by the Airport's Passur Flight Monitoring System. Wind direction and runway maintenance were significant factors with aircraft arrivals and departures.

I. Discussion of Noise Related Concerns and Audience Questions

Sub-Committee member, Bill White, asked if the 1 person with 44 complaints receives follow-ups from the Airport for each complaint. Noise Abatement Officer, Lowell Wright, responded that he follows up with each complaint either by phone, e-mail or written correspondence.

Guest, Mark Schoendorff, asked if an "Aircraft Usage by Runway" graph could be produced. FAA, Air Traffic Manager, Kathy Asselborn will check if the data is available from Air Traffic Control resources.

Guest, Blair McMillan, asked if it was necessary for the F-16 Aircraft to utilize the afterburner on the take-off every time. Lt. Col. Peltier stated that the after burners are used only when the aircraft's configuration and weight require it. Additionally, pilots are required, by procedure, to shut down the after burner when the aircraft reaches a speed of 300 knots or reaches the confines of the airfield, which ever comes first.

Guest, Mark Schoendorff, asked if the airport would do anything differently if there were more noise complaints. Noise Abatement Subcommitte Chair, Paul Rusk, indicated the Airport would increase education efforts to the public and to pilots to be aware of noise sensitive areas. The Airport has placed additional signage reminding pilots of the noise abatement procedures.

Discussion followed regarding the information available on the Airport website and difficulty navigating to noise related information.

Airport Commission Chair, Sally Probasco, and Rusk, indicated they plan to follow-up with Dane County's IT Department and the Airport's Public Information Director to improve access to noise related data.

Guest, Blair McMillan, asked if the Airport is being "cheap" on the noise abatement related efforts.

Airport Director, Livingston, indicated that our Airport rates above-average regarding its noise abatement effort.

Director of Operations and Public Safety, Mike Stephens reported it is very unusual for airports of our size to have a dedicated Noise Abatement Officer such as Dane County provides. Sub-Committee member, Bill White added that this is in addition to the public interplay opportunities the Airport provides.
