1. Friends of Anderson County Park

Roe Parker, President, Friends of Anderson County Park provided a PowerPoint presentation covering the magnitude and extent of the Friends programs, field work and overall growth of the park. Looking forward the Friends identified the following projects they would like to move forward on:

- Enhance Park Entrances Landscaping and art
- Building the Dog Park Most asked about related to need for the region
- Working with the Town/Village/County on a Bike/Ped trail connection connecting neighborhoods to the park needs to be located off Union Road due to safety issues
- Starting to develop the Agricultural Educational components
- Creating an Overflow Area as identified in the masterplan for events and activities
- Continue to work on the prairie area and picnic area site
- Expanding hiking opportunities to other locations around the property currently working in 37-acre area but the park property is over 300 acres

2. Anderson County Park - Projects and Future Planning

Marsh stated that the Friends covered the Park's Master Plan very well and their future projects. Marsh stated that the county looks forward to working with the Friends, the Town and all the partners to help develop the park and trail connection system. Marsh stated that the county is currently working on budget recommendations for 2017. There are many needs for the county and there will not be enough resources to do everything. Park staff continue to plan for the projects that are in our work plans. Some projects, such as the overflow parking area and hiking trails can be planned and moved forward while the others may take a few years. In addition, the County continues to pursue potential partners to help create expanded agricultural educational opportunities at Anderson County Park.
