AWARD OF CONTRACT TO PROVIDE COMMISSARY, INMATE BANKING AND TRUST SERVICES TO THE DANE COUNTY SHERIFF'S OFFICE JAIL

## Policy Analysis Statement:

## Brief Description of Proposal -

Request approval to award a contract to Catering by Marlin's, dba CBM Managed Services, LLC, for provision of commissary and inmate banking and trust services to the Dane County Jail commencing September 1, 2016 and continuing for three years with two one -year contract extensions.

#### Current Policy or Practice -

The existing contract for commissary services expires August 31, 2016. Dane County engaged in a competitive Request for Proposal (RFP) process, Proposal # 115104, for a vendor to provide commissary and inmate banking and trust services for inmates. Catering by Marlin's, dba CMB Managed Services, 500 East 52<sup>nd</sup> North, Sioux Falls, South Dakota, 57104, was the successful bidder in the competitive RFP process.

## Impact of Adopting Proposal -

Commissary or "canteen" is a store within a correctional facility from which inmates may purchase approved products such as hygiene items, snacks, writing instruments etc., that are not furnished by the correctional facility. CBM Managed Services will provide commissary and inmate banking and trust services for Dane County Jail inmates; the contract is commission based and CMB Managed Services agrees to pay the Sheriff's Office a composite commission of the commissary net sales of 37% with a minimum annual guarantee on the composite net sales of commissary service sales of \$250,000, which ever is greater.
