2017 BUDGET RECOMMENDATIONS FOR THE COUNTY EXECUTIVE (Action Item)

Committee members discussed the DCDHS 2017 Budget Request and testimony given at the September 15 public hearing. Committee members suggested items to recommend to the County Executive. Green and Genter answered questions about the 2017 budget. Kiefer moved, Garrett-Thomas seconded a motion that the committee send a letter to the County Executive that would include the following recommendations: a. support a 1% COLA for POS agencies, b. support the Area Agency on Aging Board's priorities of case management, guardianship and especially cultural diversity services, and c. support the restorative justice model of services for teenagers and adults including maintaining the capacity of the juvenile community court given its reduced grant funding and encouraging action/funding necessary to achieve full capacity of the under-utilized adult restorative justice court. Approved 8-0.
