2016 RES-369 2016 URBAN WATER QUALITY GRANT AWARDS

The Dane County Urban Water Quality Grant Program was included in the 2016 County Budget to
improve the quality of urban stormwater runoff entering Dane County lakes, rivers and streams, increase
public awareness of urban water quality issues, and provide public education for urban stormwater
quality improvement practices. The project goals are to be achieved through the construction of best
management practices that will provide efficient, cost-effective treatment of urban runoff. Financial
assistance is available to municipalities in the form of cost sharing.

16 In addition, the City of Madison has requested additional grant funding for two previously awarded

projects due to changes in scope and bids received. These two grants are showcase projects that are ranked one and two on the "Top Ten Outfall" list due to their potential benefit to remove sediment and phosphorus from Lakes Mendota and Monona. The requested increases in funding are still within the UWQG program limits, therefore we recommend granting the requests shown below:
