## AUTHORIZING ALLIED LEASE FOR JOINING FORCES FOR FAMILIES PROGRAM DCDHS - CYF Division

### **Policy Analysis Statement:**

## Brief Description of Proposal -

Dane County Department of Human Services is involved in a program of providing more localized services in the communities identified as needing those services most. One such program is the Joining Forces for Families (JFF) Program. The Joining Forces for Families program is renewing a lease on office space in a building owned by Cyrena Pondrom and managed by the Investment Planning Corporation and this space is located at 2225 Allied Drive, Apartments #1,2, 3 and 4, Madison, Wisconsin. This resolution is to pay for the monthly rental payment of \$2,560 per month to cover costs related to occupying this space during the lease term of twelve months (01/01/17 to 12/31/17).

#### Current Policy or Practice -

Leases require County Board approval.

#### Impact of Adopting Proposal -

Authorizes the County Executive and County Clerk to execute a lease for space for the JFF Program in a building 2225 Allied Drive, Apartments #1,2, 3 and 4. This resolution is to pay for the monthly rental payment of \$2,560 per month to cover costs related to occupying this space during the lease term of twelve months (01/01/17 to 12/31/17). The space will be utilized by a Dane County Community social worker and other JFF partners. The total rate for the term period is \$30,720. All utilities except electricity will be paid by landlord. Adequate funds are budgeted for lease payments and electric costs.
