D. Presentations

NORTHWEST DANE SENIOR CENTER MEAL PROGRAM

Northwest Dane Senior Center Executive Director Paulette Glunn reported an increase of approximately 2,000 meals being served in 2016, for a total of nearly 10,000 meals for the year. As of June 1st 2016, Northwest Dane Senior Center began utilizing Dane County Consolidated Foods as their caterer instead of a subcontracted caterer due to turnover in caterers. Lunch is served Monday through Friday at 11:30am, with an average number of 15 diners. Glunn believes this will continue to increase as the municipalities continue to grow. Additionally, Northwest Dane Senior Center is averaging 25 home delivered meals per day, covering a 192 square mile route. Glunn reported that Northwest Dane Senior Center is operating out of a building they now own and that a new Board of Directors is now in place.

E. Reports to Committee

1. HOLIDAY MEAL ACCOMODATION

Velasquez reported that she has been in contact with all dining site coordinators to discuss their plan for congregate dining sites and home delivered meals over the holidays due to Christmas and New Year falling on weekends. All sites now have a plan in place.

2. CHAIR & STAFF REPORTS

Velasquez reported that AAA staff will have a conference call in the upcoming week with Culvers to discuss a voucher program for underserved pockets of Dane County.

Velazquez reported she received the ElderACE Award for best practices from the Greater Wisconsin Agency on Aging Resources (GWAAR) in September at the Aging Network Conference. The honor recognized the implementation of the highly successful "My Meal-My Way" restaurant model that is being replicated across the state.

Velazquez reported that there is an opening on this committee. Nancy Stolla is interested in filling this position. Her name will be put before the AAA Board of Directors at their next scheduled meeting.
