Authorizing Acceptance of Grant Funds for 1.0 FTE Specialized Resource Prosecutor for the Dane County District Attorney Office

## **Policy Analysis Statement:**

#### Brief Description of Proposal -

The proposal relates to the acceptance of grant funds and creating a 1.0 FTE Specialized Resource Prosecutor position within the Dane County District Attorney Office for a second year. The position will carry a specialized Domestic Violence (DV) and Sexual Assault (SA)caseload and be a resource for Region 2, within the State of WI, that includes 18 counties related to sensitive crimes.

## Current Policy or Practice -

In the second year of the Specialized ADA grant, there will be a continued focus on a sensitive crimes caseload to include Domestic Violence and Sexual assault cases and to continue to be a resource for Region 2.

# Impact of Adopting Proposal -

Resolution will accept continued grant funds for a 1.0 FTE Specialized Resource Prosecutor position that will focus on DV/SA crimes. Under the grant, the position is funded until 9/30/17.
