1. ADRC Governing Board

Frazier reported the Aging and Disability Resource Center is enrolling more people in the partnership program (251 enrollments since January 2016). The ADRC Board is holding public hearings in spring 2017 for input on Family Care in Dane County.

County/State/Federal Legislative Update

Beil reported Legislative Council Study Groups are still ongoing. The next legislative session will begin in January. There will be upcoming changes with the November election. Beil is monitoring other counties and Family Care. Beil distributed the 2017-2019 Legislative Directory of Dane County.

Velasquez reported she is wrapping up data reports. There has been an 11,000 congregate meal increase for the year. She also reported on a recent initiative with Culvers for a meal voucher program.
