1. State and Federal Report

4. Chair & Staff Reports

Batterman reported AAA staff is extremely busy completing 2017 contracts. The AAA Clerk-Typist I-II position (formerly filled by Howard Thomas) will be unfilled for 3-4 months during the County hiring process. The duties have been reassigned to AAA staff and ADRC Clerks. An audit of the position is being requested with the hopes the position will be upgraded to a Clerk-Typist III which is more correctly reflective of the assigned duties. Legislative/Advocacy Committee Chair Esther Olson is meeting with Health & Human Needs Committee Chair Jeremy Levin to discuss the unfunded programs remaining on the 2017 AAA Budget Priorities list.

Velasquez reported AAA staff have been meeting with DHS staff and County Aging Units to propose changes to the state funding formula. If approved, this will affect 2018 Older Americans Act state-wide funding.
