E. Reports to Committee

1. ADRC Governing Board

Frazier reported the ADRC Board is holding public hearings in spring 2017 for input on Family Care in Dane County. The Board recommends forming an ad-hoc advisory committee to help plan for the transition, effective January 2018.

2. County/State/Federal Legislative Update

Beil reported that State Legislative Standing Committees have been formed. Transportation issues have different perspectives which may have negative consequences in the next state budget.

3. Wisconsin Aging Advocacy Network

Frazier and Olson summarized the last meeting. Issue papers are available on the GWAAR website. State Legislators have been attending WAAN meetings to discuss issues affecting senior adults. AAA Board Chair Clausius will consider inviting Dane County legislators to future AAA Board meetings. He also offered to attend the next Focal Point Directors' meeting to encourage more advocacy efforts in future County budgets.

4. 2017 AAA Budget

Advocacy Committee

Batterman announced the 2017 Dane County budget was approved by County Supervisors and signed by the County Executive. 82% of the funding identified in the AAA budget priorities were successfully fulfilled, thanks to the strong advocacy of the Legislative/Advocacy Committee, AAA Board, Focal Point Directors, and community members. Congratulations were extended with cake, cookies, and coffee served.

5. Chair & Staff Reports

Batterman reported Purchase of Service contracts have been submitted; contracts were amended twice to reflect funding increases awarded by the County Executive and Board of Supervisors. The retirement party for Fran Genter occurred the previous evening, honoring his 42 years of service with the County--19 as the DCDHS ACS Administrator. Bill Hanna started as the new Fiscal & Management Services (FMS) Division Administrator; he was previously Assistant Deputy Secretary/Chief of Staff to the State Secretary of Health Services and Director of Area Administration at the State and the Business Manager for Portage County Health & Human Services Department.
