G. Reports to Committee

1. Land Conservation Committee - Chair CHENOWETH

- •Welcomed all to the joint meeting of county environmental committees.
- •Provided an update on role of Land Conservation Committee.
- •Introduced Danielle Williams as a new member to the Land Conservation Committee. Williams is also a member of the UW-Extension Committee.
- •Requested updates from representatives of committees/groups present.

2. Park Commission - Bill Lunney

- •Currently working on an update to the 5-year Parks and Open Space Plan. Update will include public meetings throughout county to receive input.
- •The Lower Yahara Bike Trail is scheduled to open in September. The trail will include the longest bike/pedestrian boardwalk in Wisconsin across Lake Waubesa.
- •The Parks Endowment Fund balance has increased to almost \$350,000. This fund is used for improvements within Dane County Parks.

3. Lakes & Watershed Commission - Rebecca Power

Annual commission retreat was held earlier this month to establish goals/action items for the coming year. The items include:

- •Excess phosphorus in surface water
- ·Chlorides in surface and ground water
- · Groundwater issues- quality and quantity
- •Equality and inclusion (Explore options to improve diversity in water quality solutions)
- •Work with Stormwater Technical Committee on possible ordinance modification

4. Clean Lakes Alliance - James Tye

- •Working with the Lakes & Watershed Commission to explore opportunities on phosphorus runoff to the Yahara Lakes.
- •Have made a yearly commitment of \$100,000 to Yahara WINs for the implementation of conservation practices to reduce runoff to the Yahara Lakes.

5. Environment, Agriculture and Natural Resource Committee - Patrick Downing

- •Members of EANR Committee expressed support for the proposed Parks and Opens Plan presented at tonight's EANR meeting.
- •Revisited committee goals at tonight's EANR meeting including:
- -Holding public hearings on both the Enbridge oil pipeline and American Transmission Company powerlines
- -Holding outreach meetings throughout Dane County, possibly visiting current and potential projects
- -Endorsing the Food Council's food waste proposal
- -Re-evaluating the current Dane County Winter Manure Spreading Ordinance

6. Wisconsin Land and Water Conservation Association - Carl Chenoweth

- •Chenoweth is a member of the Land Conservation Board representing the Southern Area.
- •UW-Extension is going through a reorganization moving to a more regional approach. This might result in issues with funding and staffing at the county level.
- •Discussed the possibility of reorganization of the DNR.
