Murray will draft a motion for discussion and action at the March meeting based on today's discussion.

2. Brief discussion of CCR hours allocation

CCR's spent \$9700 of the \$10000 allocation in 2016. The LTE reimbursement rate will increase in 2017 so there will be fewer hours to allocate. Murray will contact CCR chairs.

3. Legislative Update/Announcements

- Rusk reviewed several criminal justice system reforms included in the County budget.
- Murray gave a federal level update. Repealing the Affordable Care Act would have dramatic effects on systems that victims and marginalized populations rely on. The resolution includes total defunding of planned parenthood which would significantly reduce family planning options. The proposal to block grant Medicaid to reduce the Federal Government's responsibility would affect victims of sensitive crimes.
- McKinney reported that the City has allocated dollars to support diversion programs in identified communities. She noted that the Ordinance prohibiting individuals from standing on medians is a public safety issue and not meant to be against homeless. The City Council is also addressing activities on State Street.
- Murray requested that each CCR identify a person to be responsible for updating the website and send their email information to him.

- •Domestic Violence: Murray will forward Diara William-Sturtevant's update.
- •Elder Abuse: Scarr gave an update on FAST and the Hoarding Task Force. The CCR is working on events for World Elder Abuse Awareness Day which is June 15, 2017.
- •Sexual Abuse: Sathasivam reported that the next meeting is on January 27. They will be discussing previously unsubmitted SA kits and WCASA legislative initiatives. Miyasaki gave a CCSEC update.
