## Dane County Land Conservation Cost Containment Policy:

Cost sharing is based upon the actual cost of the project not to exceed calculated average costs unless a participant receives three bids demonstrating construction costs will be greater than calculated average costs. Maximum cost share will then be based upon the lowest bid submitted.

Attached is the proposed 2017 Average Costs for the installation of Conservation Practices. This is developed as part of Dane County Land Conservation's Cost Containment Policy. The unit costs are used for providing landowners with an initial estimate of construction costs, developing cost share agreements and as a basis for determining maximum cost share reimbursements. Projects constructed in 2016 and prior years were used to develop the 2017 Average Cost List.
