F. Presentations

Friends of Silverwood County Park - Mark Doudlah

Katie Whitten introduced everyone in attendance for the Friends of Silverwood Park. Emily Halapatz explained a letter that was sent from the Friends of Silverwood to the Park Commission earlier in the day. Halapatz stated that the intent of the letter was to express the Friends' desires to see that all of the agricultural lands at Silverwood be transitioned to organic agriculture. She stated that it takes three years for lands to become certified as organic.

Mark Doudlah, Farmrite Organics, stated he was a regular farmer that has changed over time to accommodate the requests of the new educated consumer. "I currently manage ~1,500 acres in organic agriculture. In 2017, I will be transitioning 24 acres into organics at Silverwood. I also use other county lands including the Lower Mud Lake Natural Resource Area. My family began moving towards organic agriculture in 2008 when my dad came down with cancer. We converted 40 acres over to organics in his name. Since then we have grown to about 1500 acres and solely manage for organics. We are taking wornout land, lands that have very little organic matter remaining, and rebuilding the soils to improve them. We broke free from our dependency on synthetic fertilizers and pesticides to raise our crops. Organics can be the solution to improving our environment. Organic agriculture has come a long way in its research to keep valuable soil in place by keeping green crops on the land. Our yields may not be as high as the genetically modified grains that accommodate herbicide treatments, but our crops are better for the environment and not adding to the growing amounts of pesticides in our food supply. I am pleased to be working with the Friends of Silverwood County Park and believe the park could be a top educational facility showcasing and promote organic agriculture."
