Policy Analysis Statement:

Brief Description of Proposal -

The Wisconsin Department of Justice, Division of Law Enforcement Services, Training and Standards Bureau/Justice Programs, is providing grant funding, in the amount of \$4,500, for a training course for the Wisconsin law enforcement community and criminal justice part ners. Course subject matter, presented by Lifeguard Systems Inc., will cover topics related to aquatic deaths and homicidal drowning investigation s including scene approach, case histories, witness interviews, statement analysis, post mortem physiology forensics, evidence, court ready doc umentation, and other topics.

Current Policy or Practice -

Acceptance of grants requires approval of the County Board.

Impact of Adopting Proposal -

Law enforcement and medical personnel are not trained to recognize the red flags specific to homicidal drownings. The goal of this training is to assist law enforcement personnel to search for and identify signs of foul play and to follow best practice procedures to document all evidence details of homicidal drowning cases.
