Statutory Responsibility

- For the well-being, treatment and care of the mentally ill, developmentally disabled, alcoholic and other drug dependent citizens residing within its county.
- Limited to the programs, services and resources that the county board of supervisors is reasonably able to provide **within the limits** of available state and federal funds and of county funds required to be appropriated to match state funds.

§51.42(1)(b)

- Individuals who need treatment for substance use or withdrawal management.
- Individuals in crisis.
- Individuals who meet the eligibility criteria for other earmarked State funded programs and grants.






Expenditures - AODA






DCDHS Actual Adult Mental Health Expenditures by GPR and Revenue 2012-2016 and 2017 Estimate
