AUTHORIZING REALLOCATION OF POSITION AUTHORITY FOR AN ASSISTANT COUNTY VETERANS SERVICE OFFICER POSITION IN THE DANE COUNTY VETERANS SERVICE OFFICE

Policy Analysis Statement:

Brief Description of Proposal -

As currently staffed, the Veterans Service Office consists of six staff members: one Clerk-Typist III and five Service Officers (a Veterans Service Officer, an Assistant Veterans Service Officer-Supervisor, and three Assistant Service Officers). The Office wishes to split one of the 1.0 FTE Assistant Service Officer positions into two .50 FTE Assistant Service Officer positions to give the office increased flexibility.

Current Policy or Practice -

Creation/reallocation of position authority requires approval of the County Board.

Impact of Adopting Proposal -

With a staff of six personnel, it is becoming increasingly difficult for the Veterans Service Office to provide adequate coverage during key outreach events and to maintain adequate staffing. Another factor driving this staffing challenge is the policy to maintain at least two personnel in the office at all times, a policy driven by customer service and safety concerns. The split of a 1.0 FTE Assistant Service Officer position will offer increased flexibility and "surge capacity" to provide coverage during high-demand periods, allow the office to better serve the community, in-house and during outreach activities.
