## **Zoning District Boundary Changes**

#### A-1EX to RH-1

A part of the NW ¼-NE ¼ of Section 11, Town 5 North, Range 6 East, Town of Perry, Dane County, Wisconsin, described as follows: Commencing at the North ¼ corner of said Section 11; thence S 01° 03'42" E, 164 feet along the West line of the NE ¼ of said Section 11 to the point of beginning; thence N 88° 56'18" E, 283.00 feet; thence S 01° 03'42" E, 300 feet; thence S 85° 49'30" W, 283.42 feet; thence N 01° 03'42" W, 315.39 feet to the point of beginning, containing 2.0 acres net.

#### A-1EX to RH-1

A part of the NW ¼-NE ¼ of Section 11, Town 5 North, Range 6 East, Town of Perry, Dane County, Wisconsin, described as follows: Commencing at the North ¼ corner of said Section 11; thence S 01°03'42" E, 760.00 feet along the West line of the NE ¼ of said Section 11 to the point of beginning; thence N 88°56'18" E, 346.00 feet; thence S 04°47'44" E, 33.06 feet; thence S 74°49'00" W, 284.40 feet; thence S 21°05'00" E, 190.26 feet; thence S 80°03'32" W, 139.15 feet; thence N 01°03'42" W, 302.62 feet to the point of beginning, containing 0.83 acres net.

#### RH-1 to A-1EX

A part of the NW ¼-NE ¼ of Section 11, Town 5 North, Range 6 East, Town of Perry, Dane County, Wisconsin, described as follows: Commencing at the North ¼ corner of said Section 11; thence S 01°03'42" E, 880.58 feet along the West line of the NE ¼ of said Section 11; thence N 74°49'00" E, 359.00 feet to the point of beginning; thence N 74°49'00" E, 65.60 feet; thence S 21°05'00" E, 280.00 feet; thence S 74°49'00" W, 350.00 feet; thence N 21°05'00" W, 89.74 feet; thence N 80°03'32" E, 227.30 feet; thence N 04°47'44" W, 213.52 feet to the point of beginning, containing 1.06 acres net.

# **CONDITIONAL ZONING**

Conditional zoning is hereby imposed pursuant to Section 10.255(3)(a)2.(b) of the Dane County Code of Ordinances. The rezoned area shall be subject to the following conditions.

### **CERTIFIED SURVEY REQUIRED**

The above listed description/s is/are intended to describe land for which a certified survey map will be prepared for approval and recorded. Within 90 days of rezoning approval by Dane County, a *final* certified survey map that describes the land to be rezoned shall be prepared in accordance with all applicable provisions of Chapter 236 Wisconsin Statutes and Chapter 75 Dane County Code of Ordinances, and submitted to the Dane County Zoning Division. Upon submission of the final certified survey map, the Zoning and Land Regulation Committee, or its authorized representative, shall, within 30 days, approve, approve conditionally, or reject the certified survey map. Failure to submit the final certified survey within the 90 day period <u>and/or</u> failure to record the survey with the Dane County Register of Deeds will cause the rezone to be null and void. Two copies of the recorded survey shall be submitted to Dane County Zoning.
