#### G. Reports to Committee

1. Stormwater Technical Advisory Committee report - next steps

The Executive Committee (Exec) recommends that the Commission not convene a new work group, rather Exec will discuss recommendations of the Technical Advisory Committee and bring a proposal to the full Commission. Exec will invite Jeremy Balousek to attend their meeting as a resource, and POWER will contact the Capital Area Regional Planning Commission about how best to collaborate moving forward on the recommendations.

#### 2. Joint and dispersed meetings planning

Silverwood County Park did not work for the June 8 meeting due to logistical issues but could be an option for a future Commission or joint meeting. Other location ideas: Waunakee Village Hall, DeForest or Fish Lake. The Commission will continue to plan meetings away from downtown Madison when possible.

3. Review work groups progress (Phosphorus, Chlorides, Equity)

Phosphorus: Healthy Farms, Healthy Lakes will be voted on tonight at County Board. Members want to discuss possible budget items addressing leaves with Clean Lakes Alliance, Christal Campbell and Jeremy Balousek; then convene the phosphorus work group to talk about budget recommendations (due in July for August public hearing).

Chlorides: The contract was signed to move forward with application rate development for parking lots and sidewalks. MCCARVILLE, Jones, and RIPP are meeting with Pam Dunphy when Jones returns from vacation.

Equity and Inclusion: Simpson Street Free Press interns are starting in June, and the next work group meeting is scheduled for June 13.
