## APPROVING A CONTRACT FOR THE "UNIVERCITY" ALLIANCE

#### **Policy Analysis Statement:**

Brief Description of Proposal -

The resolution awards \$40,000 to the UW-Madison for the UniverCity Alliance project. Cross-disciplinary teams from existing UW-Madison courses will work on policy development and evaluation projects regarding the topics of economic development, affordable housing, approaches to help heavy users of county services, and water quality management. Up to 20 courses from across UW-Madison will participate and produce a multi-faceted report.

Current Policy or Practice -

County departments may work with individual professors and their courses on a case by case basis. This is the first opportunity to engage with faculty across a continuum of disciplines simultaneously to further policy development.

Impact of Adopting Proposal -

The county will benefit from a broad array of inquiry on four specific policy areas. This is an opportunity to further the relationship between the UW and Dane County, introduce students to the county as a future employer, and to solve critical issues. Funding is available in the County Board Office budget audit line.
