





Assists victims of crimes who are 60 and over in Dane County:


- *Exercise their legal rights











EAN/AAR HELPLINE

2013 – 1031 phone calls received = 19,263 minutes = 321 hours or 107 hours per worker

2014 – 2212 phone calls received = 32,155 minutes = 536 hours or 179 hours per worker

2015 – 2041 phone calls received = 29,189 minutes = 486 hours = 162 hours per worker


2016 – 2397 phone calls received = 572 hours = 191 hours per worker

79% increase in amount of time spent on phone calls from 2013 - 2016





Types of Elder Abuse




2016 Alleged Abuser's Relationship to Elder Abuse Victim




