Randy,

See the attached map. I have made notations at each test hole location indicating depth to mottling (seasonal saturation based on profile color pattern), saturation levels (some of the clay layers were saturated but water was not necessarily running into the pit), depth to bedrock (B-5) and the depth of the sandy loam glacial till (the good stuff in the southeastern portion).

I also drew dashed lines delineating the areas suitable for the various types of septic drainfields. From no good for nothing in the northwest corner, to mounds only, to at-grades or mound, to in-ground conventional systems to the southeast. After you get your roads and lots figured out, let me see what you have on paper and I will tell you if and where we might want some additional holes to refine the picture.

I should be able to write up the logs on the test pits before the end of the week and get those over to you. I will use the "SOIL EVALUATION-STORM" form so your engineer can use these for the stormwater management plan that I'm sure will be in the works.

Let me know if you need anything else. Thanks.
